RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AND PARENTAL CONSENT AGREEMENT ("AGREEMENT")

IN CONSIDERATION of being permitted to participate in any way in B.C. TIGERS SPORTS CLUB Activities ("Activity") I, for myself for personal representatives, assigns, heirs, and next of kin:

- 1) ACKNOWLEDGE, agree, and represent that I understand the nature of B.C. TIGERS SPORTS CLUB Activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.
- 2) FULLY UNDERSTAND THAT: (a) B.C.
